# Access & Equity in Mobility Today

# 30 years after the passage of the Americans with Disabilities Act

- Public buses are accessible, yet
- Many bus stops, sidewalks, and transit stations are not accessible
- Passenger vehicle accessibility extremely limited & expensive
- Limited access to broadband and tech in marginalized communities
- Accessibility has been an afterthought for new modes & services
  - Real world impacts -> Uber & Lyft providing free rides to vaccine sites. Few accessible vehicles in their fleets.

### The Autonomous Vehicle Promise

### Potential to Transform Mobility & Lives, if

- Vehicles are designed to be safer and fully accessible for all, including people with disabilities and darker skin tones
- Accessible public rights-of-way and access to broadband and tech is prioritized
- We learn from the past and require integration at the outset,
   pushing back against the 'we'll get to accessibility later' mindset
- AV services meet needs and marginalized communities are engaged and leading at every level

# DREDF AV Access & Equity Needs Checklist

#### Universal Design & Accessibility Policies

- Human Machine Interface (communication, identifying the vehicle ...)
- Vehicle Hardware (including securement, ramps)
- Policies
  - Anti-discriminatory licensing and insurance
  - Accessible AV crashworthiness, occupant & pedestrian safety requirements
  - o Improved infrastructure (sidewalks, curb cuts, and broadband access)
  - Funding for travel training

#### **Equity Policies**

- Ensure benefits and access for low income, BIPOC, underserved communities
- Workforce transition plans
- Title VI of the Civil Rights Act, Environmental Justice and ADA compliance
